Minnesota State Grant - Determination of Resident Status

Use this side of the form to determine if you should complete the Questionnaire on the reverse side.

You must meet ALL of the following criteria to be eligible for a Minnesota State Grant:

- Must not have completed a bachelor's degree
- Must not have completed four years or the equivalent of four years of education beyond high school
- Must plan to attend a college in Minnesota and enroll in an undergraduate program in coursework leading to a diploma, certificate or degree
- Must not be in default on a federal student loan or a state SELF loan
- Must not owe the Office of Higher Education for a State Grant overpayment
- Must not be more than 30 days past due on a child support obligation
- Must be meeting federal and state requirements for Satisfactory Academic Progress

You must meet AT LEAST ONE of the following criteria to be eligible for a Minnesota State Grant:

- Be considered a MN resident under the MN Dream Act
- By July 1, 2024, you will have graduated from a Minnesota High School while residing in Minnesota.
- You did or will reside in Minnesota for twelve consecutive months before becoming at least a half time student at a Minnesota school beyond high school.
- By July 1, 2024, you will have received a GED in Minnesota after residing in Minnesota for twelve months. (A GED is a high school equivalency certificate that is granted to students who did not graduate from high school, but passed a high school equivalency test.)
- You are a dependent student whose parent resides in Minnesota at the time the FAFSA is completed.
- You are a member, spouse, or dependent of a member of the armed forces of the United States who is stationed in Minnesota on active federal military service as defined in section 190.05, subdivision 5c.
- You are a spouse or dependent of a veteran who is a Minnesota resident.
- You or your spouse relocated to Minnesota from an area that is declared a presidential disaster area within the preceding 12 months if the disaster interrupted your or your spouse's postsecondary education.
- You are a refugee under United States Code, title 8, section 1101 (a)(42), who upon arrival in the United States, moved to Minnesota and have continued to reside in Minnesota.

The amount of a State Grant is based on financial need. The state grant formula takes into consideration the school's cost of attendance, the expected student or parent contribution and the amount of the student's Federal Pell Grant. The cost of attendance used to calculate the full-time State Grant is based on a student enrolling for 15 credits per semester and will be reduced if a student enrolls for less than 15 credits per semester.

All awards are subject to the availability of Minnesota State funds.

DEADLINE – Students applying for a Minnesota State Grant must also submit the Free Application for Federal Student Aid (FAFSA). The FAFSA must be received by the Federal Application Processing Center no later than 30 days after the start date of the first term for which a State Grant is requested.
